By Representative Johnson:

HB110 To amend Section 41-4-302 of the Code of Alabama 1975, to provide for certain elected county officials and their employees who are required to be bonded to be covered under the state blanket bond under certain conditions.

Finance and Taxation General Fund Number of amendments: 0

FISCAL NOTE

House Bill 110 as passed the House of Representatives would allow certain elected county officials and their employees who are required to be bonded to be covered under the state blanket bond if the Governor determines that extending the blanket bond will be in the best interest of the state. This bill could decrease bonding obligations of the counties by an undetermined amount dependent upon the difference between the amount counties currently pay and the state amount charged for bonding. In addition, the increased exposure resulting from bonding the county elected officials could increase the premiums paid by the state under the state blanket bond.

HB188 To amend Sections 41-9-251, 41-9-252, and 41-9-253, Code of Alabama 1975, relating to the Cahaba Advisory Committee, to provide for the selection of the chair and other officers; to provide for a minimum per diem and for travel expenses for attending official meetings and performing service for the committee; to provide for employee benefits; to make technical and spelling changes; and to provide additional powers to the committee, including making appropriations and expending funds, making grants, contracting with others for preservation, and acquiring and disposing of properties relating to the Old Cahawba Capital Site.

Agriculture, Conservation, and Forestry Number of amendments: 0

FISCAL NOTE

House Bill 188 as passed the House of Representatives authorizes an additional \$150 per diem allowance per member and could increase the obligations of the Cahawba Advisory Committee, paid from State General Fund appropriations and other sources, by an estimated minimum of \$4,500 for the fiscal year ending September 30, 2003 and by an estimated minimum of \$9,600 each fiscal year thereafter to pay the additional per diem meeting expenses of Committee members plus mileage. The bill will also increase the obligations of the Committee by an undetermined amount, to pay expenses of 1 member as approved by the chair, for official duties performed at other times and also for providing additional compensation to the secretarytreasurer, as approved by the Committee, for clerical expenses. The bill provides additional powers to the Committee, including: (1) appropriating and expending funds, making grants, and cooperating financially with the Alabama Historical Commission and other entities; (2) acquiring title to and taking possession of properties and objects; (3) having the option to provide employment protection to Committee employees; and (4) leasing, selling and disposing of surplus or unused properties. This bill could reduce the ad valorem tax receipts to the state and local governments if currently taxable property is acquired by the Committee and is taken off the tax rolls.

SB369 To amend Section 5-18-15, Code of Alabama 1975, relating to the Alabama Small Loan Act, to provide in connection with loans for a loan charge on loans made by licensees under the act as an alternative to interest and for certain handling charges in connection with the loans.

SB33 To amend Section 36-21-13, Code of Alabama 1975, relating to compensation paid to state police officers utilized by certain state departments or agencies for injuries in the line of duty, to provide for a retroactive effect.

FISCAL NOTE

Senate Bill 33 as introduced makes the provisions which require state agencies that utilize fulltime state law enforcement officers (including correctional officers of the Department of Corrections and excluding the State Board of Medical Examiners) to continue to pay an officer injured in the line of duty at his or her normal salary and benefits instead of two-thirds of the normal salary provided to other injured state employees and paid by the State Employee Injury Compensation Trust Fund retroactive to December 28, 1999 rather than the current effective date of May 23, 2000. For persons who become eligible under this retroactive period, this bill would result in a decrease in compensation benefits expenditures from the State Employee Injury Compensation Trust Fund and will increase personnel costs paid by employer agencies of injured officers by an amount dependent upon the number of injured officers, their salaries and length of time out of work.

SB393 To establish the Alabama Nursing Home Residents' Bill of Rights; to define elder abuse and elder fraud; to provide exclusive civil remedies for elder abuse superseding any existing statutory law; to provide certain reporting requirements in the event of death of a resident; to provide certain staffing hours and minimum ratios for staff and nurses to residents in nursing homes; to require criminal background checks on nurses, staff, and volunteers in direct care positions in a nursing home; to require the disclosure of information relating to persons involved in the licensing and operation of a nursing home and requiring that the information be made available to the public; and to authorize the Department of Public Health to promulgate rules and

regulations to implement, administer, and enforce this act.

FISCAL NOTE

Senate Bill 393 as introduced will increase the obligations of the Alabama Department of Public Health (ADPH) by an undetermined but substantial amount to perform additional nursing home inspections and surveys as provided for in the bill.

SB315 To amend Section 11-45-9 of the Code of Alabama 1975, providing for the penalties for violations of municipal ordinances; to further provide that the fines for driving under the influence (DUI), reckless driving, and operating a vessel under the influence provided in municipal court may be the same as the fines provided by state law.

Number of amendments: 0

FISCAL NOTE

Senate Bill 315 as introduced would decrease the current maximum fine of \$5,000 upon first convictions for DUI municipal ordinance violations to maximum fines of \$2,100, which could result in decreased receipts to the State General Fund and certain municipal general funds. This bill would increase the current maximum fine of \$5,000 upon second or third or subsequent convictions for DUI municipal ordinance violations to maximum fines of \$5,100 for second convictions and \$10,100 for third or subsequent convictions, which could result in increased receipts to the State General Fund and certain municipal general funds. The overall impact to the State General Fund will be dependent upon several unknown factors, such as the number of violations and whether the conviction is a first or subsequent conviction, and the amount of the current fines. This bill also increases the current maximum fine upon conviction of violating municipal ordinances prohibiting operation of a vessel or other marine device while under the influence, from the current maximum of \$500 to maximum fines of \$2,100 for first convictions, \$5,100 for second convictions and \$10,100 for third or subsequent convictions. However, it is not anticipated that this will significantly increase receipts to the State Water Safety Fund or any other state or local funds.

House Bill 148 as passed the House of Representatives could increase receipts to the State General Fund from fines upon conviction of unlawful possession of anhydrous ammonia as further defined by this bill and could also increase the obligations of the Board of Pardons and Paroles and the Department of Corrections by an amount dependent upon the number of convictions for those offenses.

HB196 To amend Section 27-1-17, Code of Alabama 1975, relating to the payment of claims, to prohibit insurers, health service corporations, and health benefit plans from requiring refunds of paid claims after 12 months from the date the health care claim was paid or after the expiration of the same period of time that the health care provider is required to submit claims pursuant to a contract between the health care provider and the insurer, health service corporation, or health benefit plan, whichever date occurs first.

House Bill 218 as passed the House of Representatives includes podiatrists and podiatric corporations and associations under the Alabama Medical Liability Act of 1996. This bill will not affect state or local funding.

FISCAL NOTE

House Bill 660 as passed the House of Representatives proposes a local constitutional amendment for Macon County which, if ratified would allow the operation of bingo games by non profit organizations for charitable, educational, or other lawful purposes. This bill will increase the proclamation expenses of the Governor, paid from the State General Fund, by an estimated \$600 for the fiscal year ending September 30, 2005.

FISCAL NOTE

House Bill 163 as introduced and as amended and reported by the Committee on Local Legislation could increase the employer contribution paid by Jefferson County for employees in the General Retirement System of the county by an actuarially determined .90% of total active member payroll, or the equivalent of \$1.28 million annually over a 20-year amortization period, if all members convert allowable unpaid service as allowed in this bill. This amount does not include additional matching funds and interest the county would also be required to pay.

All fees collected by the Board will be deposited in the Alabama State Board of Prosthetics and Orthotics Fund.

Senate Bill 357 as introduced could increase termination costs paid to state employees for up to 80 hours (10 days) by an amount dependent upon the number of employees who choose to accrue the additional days and the usage of those days. The cost to the several state agencies of an additional 10 days termination pay currently averages \$1,450 per employee.

A tax exempt state agency, the GMA shall be governed by 15 non-compensated board members and is authorized to 1) receive any and all types of contributions, including state appropriations, 2) expend any funds that it may receive, 3) employ employees as are necessary, and 4) establish and promulgate rules concerning the Complex.
